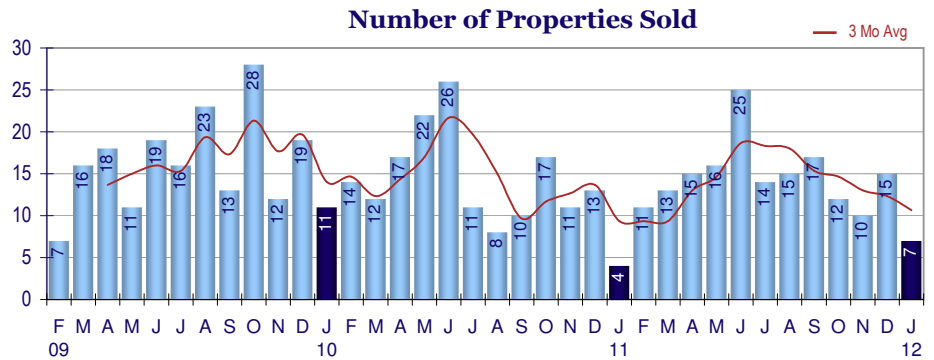

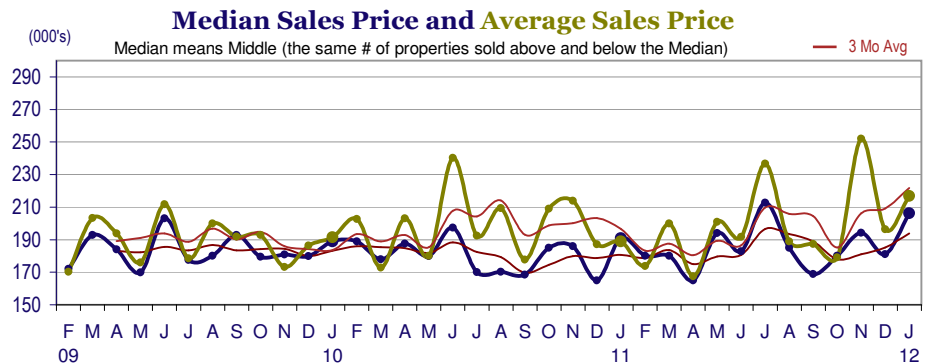
Property Sales

January Property sales were 7, up 75.0% from 4 in January of 2011 and 53.3% lower than the 15 sales last month. January 2012 sales were at a mid level compared to January of 2011 and 2010. January YTD sales of 7 are running 75.0% ahead of last year's year-to-date sales of 4.



Prices

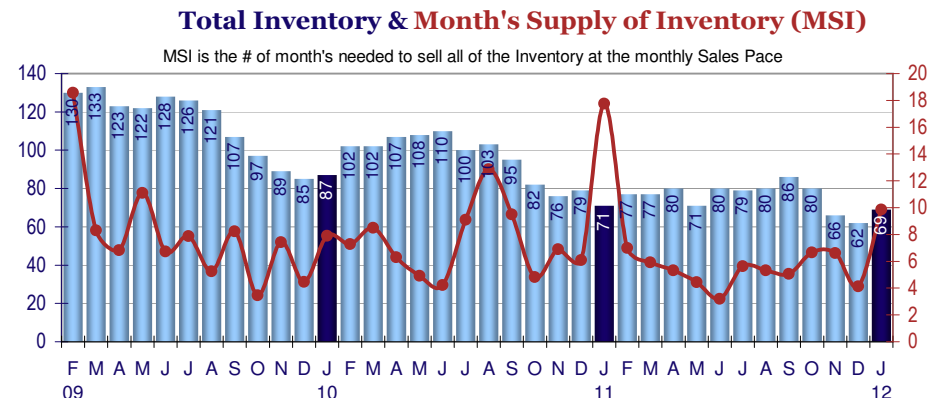
The Median Sales Price in January was \$206,200, up 8.0% from \$190,839 in January of 2011 and up 13.9% from \$181,100 last month. The Average Sales Price in January was \$216,800, up 14.8% from \$188,915 in January of 2011 and up 10.4% from \$196,427 last month. January 2012 ASP was at the highest level compared to January of 2011 and 2010.



Inventory & MSI

The Total Inventory of Properties available for sale as of January was 69, up 11.3% from 62 last month and down 2.8% from 71 in January of last year. January 2012 Inventory was at its lowest level compared with January of 2011 and 2010.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The January 2012 MSI of 9.9 months was at a mid level compared with January of 2011 and 2010.

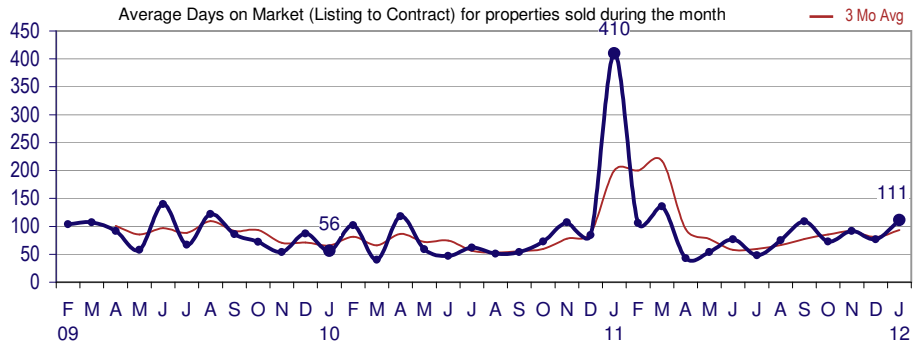

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for January was 111, up 44.2% from 77 days last month and down 72.9% from 410 days in January of last year. The January 2012 DOM was at a mid level compared with January of 2011 and 2010.

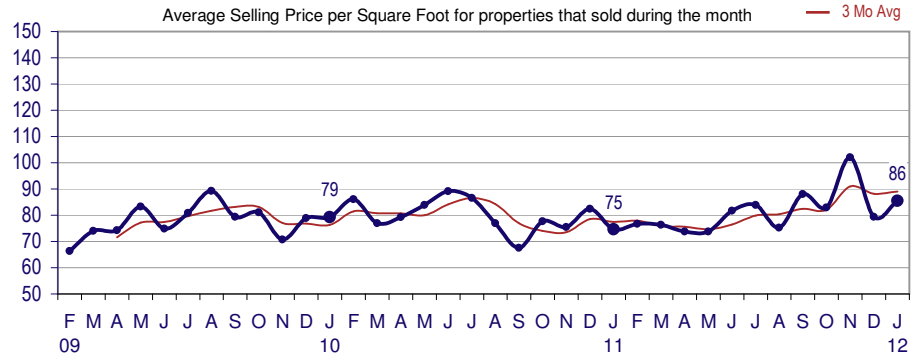
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The January 2012 Selling Price per Square Foot of \$86 was up 7.7% from \$79 last month and up 14.6% from 75 in January of last year.

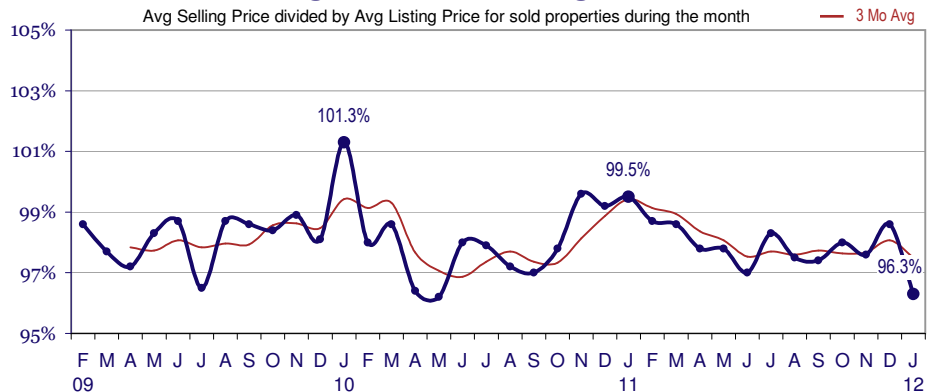
Selling Price per Square Foot



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The January 2012 Selling Price vs Original List Price of 96.3% was down from 98.6% last month and down from 99.5% in January of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in January 2012 was 18, up 157.1% from 7 last month and up 5.9% from 17 in January of last year.
